Police Report: No police officer attended the meeting. A police report was received in respect of January (attached). Fiona has asked for a report covering the whole period since the last report was received on 9th September 2019.

MATTERS ARISING FROM PREVIOUS MEETINGS

Community Resilience Checks:

Checks in Garlogie, Lyne of Skene and Echt are now completed. Kirkton of Skene and Dunecht are still to be confirmed. Nick has updated the paperwork for the folders and this was passed on to the respective members.

Forbes Park Landscaping: Council Planning Enforcement Officers visited to inspect the health of the trees in late 2019. No action from Kirkwood Homes yet. **Action**: Fiona to contact Kirkwood Homes.

Road Salt Piles: Iris advised the salt piles are for treating pavements and other public access areas. Members of the public are welcome to use the salt for these purposes. The salt piles have been replenished but the council has no plans to contain them as it is easier to load the pavement spreaders from a loose pile. **CLOSED**

Echt Hall Car Park Fly-Tipping: No change since last meeting. **Action**: Fiona to follow up with Waste department

Echt Hall Public Convenience Demolition: No change since last meeting. **Action**: Fiona to follow up with Tom Buchan.

Flooding on Kirkton of Skene to Westhill footpath: The blocked drains close to the Westhill Community Church have been cleared by Roads Department. **Action**: Fiona to contact Roads (Brian Strachan) to discuss options to mitigate flooding for the other two low points on the path.

Barmekin Park House Occupancy: The actual tenant has moved back into the property and is in the process of repairing damage. Thanks were expressed to Cllr McKelvie for prompting Housing department to investigate. **CLOSED**

Correspondence:

• An email was received from VE Day 75 enquiring whether any events were being planned in the area to mark the 75th anniversary of VE Day on 8th May 2020. The members were not aware of any plans.

AOCB:

- Westhill Swimming Pool closure for refurbishment 16th March to 10th April.
- Banchory Sports Village located at Hill of Banchory and officially opened in January by Camilla, it has a swimming pool.
- Westhill and Elrick CC Member nominations are invited from Westhill residents and business owners for the reformed community council to be submitted by 20th February (https://westhillelrick.org/)
- Red Star Inn, Kirkton of Skene— there had been a complaint about a car being obstructed when
 parked next to the Red Star. Iris advised that Aberdeenshire Council sold part of the car park to the
 owner of the Red Star when an application was submitted for the redevelopment of the rear
 function room, and so there are now a number of car parking spaces adjacent to the pub which are
 privately owned and may be marked as such. The pub lounge has now opened as Hosie's Fish and
 Chip establishment.
- The Village Store, Kirkton of Skene it was noted the shop may be in some difficulty and is currently closed.
- Echt School Parking it was noted that cars dropping off/collecting children from the school were being parked along the main road and sometimes crowded the zebra crossing.
- Echt Flashing 30mph Signs Paula reported the signs north and west of the crossroads are not working/damaged. She will report the fault via Council website.
