Minute of Meeting held 1st June 2023 at Dunecht Hall

Minute of last meeting: Approved

Police Report: Police Report received for April-May. There were 3 road accidents reported during the period and 1 motorist charged with speeding in the 20 mph primary school limit. Echt residents asked if the Police could do more speed checks in Echt. **Action:** Fiona to feed back to the police

SSEN Consultation on Proposed new Kintore to Tealing 400kV OHL: SSEN held a public exhibition at Milne Hall on 9th May. Subsequently, a group of Kirkton of Skene residents did a leaflet drop of houses within the preferred route corridor and arranged a public meeting on 25th May to raise awareness. The meeting was advertised on local social media groups as well and was very well attended, and included residents from all ESCC settlements. The deadline for the submission of comments on the scheme has been extended to 23rd June. At least three anti-pylon FB groups along the proposed route have been formed, and Andrew Bowie MP is also taking action following representations from constituents. All residents are encouraged to give their views to SSEN.

MATTERS ARISING FROM PREVIOUS MEETINGS

A2B Bus Service: Council Transport Unit consulted on 4 options for expanding the service for Echt. They sent direct letters only to people who used the service in the last 3 months but anyone could respond. ESCC also advertised the consultation and received 7 responses which were forwarded to the Council. We await further news.

Speeding Issues in Dunecht, Echt, Garlogie, Lyne of Skene and Mason Lodge: No update from Chris. Echt residents at the meeting complained about frequent HGV movements on the B977 at South Kirkton (believed to be associated with the SSEN OHL upgrade from 275 to 400 kV) making it even more hazardous for pedestrians where there is no footpath. Action: Fiona to write to SSEN project team

Community Action Plans: Kirkton of Skene CAP Steering Group held their validation event at the Milne Hall on 27th May and are now collating the results of the 36 people who attended in person, as well as others who submitted their responses online via a QR code.

Echt CAP Steering Group still needs to recruit new members, including a Chair, from the village, before the CAP process can move forward here. Echt residents questioned why the South Kirkton footpath and glass recycling bins were no longer on the ESCC agenda. Chair responded that ESCC needs to be able to demonstrate these items are supported by a majority of residents before they can be put to the Council. **Action**: Fiona to send wording to Paula for her to advertise for new Steering Group members via the residents' email list and noticeboard.

Flooding at Greystones: Scottish Water work appears to have been completed to reroute the water supply pipes away from the culvert but confirmation will be sought from them that this is the case.

Echt Playpark Improvements: Paula will be discussing the suggestions from residents for playpark improvements with Landscape Services.

Burnside Footpath: No update.

Proposed Dunecht Footpath: The project was awarded funding from the Garioch Area Strategic Budget on 30th May to carry out first stage feasibility.

Hill of Fare Proposed Wind Farm: 6 Community Council Chairs (or their deputies) met again on 15th May and agreed to ask RES for tables at their second round of public exhibitions so that we can do our own parallel survey of opinions again. We were asked by the ECU to comment on the Gatecheck report submitted by RES (this is to ensure they've covered all the matters required before submitting the final application). ESCC responded to say no consultation had been carried out with the CC's on viewpoints for the LVIA, contrary to the ECU's Scoping Opinion recommendation.
