Police Report: Police Report received for June. There were 5 road accidents reported during the period and 1 drugs offence (cannabis). Police have done speed checks in Echt – no charges made. Pop-Up Bob had also been deployed. It was noted that Pop-Up Bob is effective at deterring speeding whilst in place.

MATTERS ARISING FROM PREVIOUS MEETINGS

A2B Bus Service: Council has added a Thursday service to Banchory following the consultation. CLOSED.

Speeding Issues in Dunecht, Echt, Garlogie, Lyne of Skene and Mason Lodge: No update from Chris regarding Dunecht. Question was raised as to when speed surveys were last carried out in Garlogie, Echt and Lyne of Skene. **Action**: Fiona to review dates of last speed surveys and request repeats if more than 4 years ago.

Following last year's survey of Garlogie residents regarding speeding, it was agreed ESCC would contact Roads department to discuss additional traffic calming measures in Garlogie. **Action**: Fiona.

Community Action Plans: Kirkton of Skene CAP Steering Group is meeting on 21st July to review the validation events results and discuss next steps.

No progress on recruitment of new Echt CAP Steering Group members.

Flooding at Greystones: Scottish Water work has been completed and the water supply pipes have been removed from the culvert. **CLOSED**

Echt Playpark Improvements: Council Landscape Services is happy to proceed with residents' suggestions for park improvements (new path and wooden Gruffalo sculpture for the copse at the SE corner, more spring bulbs and relocation of a bench). Paula has costed the proposals at around £2000 excluding the aggregate for the path. **Action**: Paula to approach Breedon regarding potential donation of aggregate.

Burnside Footpath: No update.

Proposed Dunecht Footpath: No update.

Hill of Fare Proposed Wind Farm: RES public exhibitions took place w/c 12th June. Fiona and George attended the Echt event and handed out questionnaires. 360 responses received in total so far (online and paper) following all 4 events of which 75% object and 12% support. HoFWIG ran two "Know The Issues" events in Midmar and Banchory. CC Chairs meet again on 14th August to discuss survey results.

SSEN Consultation on Proposed new Kintore to Tealing 400kV OHL: The deadline for the submission of comments on the scheme has been extended to 28th July. Some other Community Councils have submitted responses. It was agreed that ESCC should do the same since concerns have been raised by large numbers of area residents. Action: Fiona to draft submission
