Minute of last meeting: Approved

Police Report: No report had been received since the last meeting. No issues were raised in relation to Policing.

Skene Paths Group: Fiona had a meeting with the new Dunecht Estate ranger, Sandra Crighton, at the Kirkton of Skene football field to discuss the community's ideas for improvement. Sandra had arranged for the acre of rosebay willowherb to be cut down by the Estate on the day of the meeting, and the new forestry manager has been asked to cut down three dead/dying trees as time allows. A revised volunteer workplan is to be submitted for review by DE.

Fiona had also raised with Aberdeenshire Council the fallen oak tree which is blocking the core path along the Kirkton House drive. Landscape Services has agreed to remove it.

MATTERS ARISING FROM PREVIOUS MEETINGS

Community Resilience: Nick/Neil are going to apply to Aberdeenshire Council for funding for two 2kWh power banks costing £1100 each. The balance of cost would be borne by ESCC. Nick is still aiming to set up a meeting prior to the onset of winter.

Hill of Fare Proposed Wind Farm: CCs will be speaking at the Community Hearing on Monday 8th September 6.30-9.30pm, and also at the Conditions Hearing on 10th-11th September. Fiona will represent ESCC. Residents are invited to attend to show the strength of feeling against the proposal.

SSEN Kintore to Tealing 400kV OHL Proposal: Westhill Library agreed to host a hard copy of the Section 37 application to be provided by SSEN once the application has been submitted.

Litter Picking: Paula Houston hasn't had any contact from Waste Services yet with respect to proposed dates for roadside litter picking by the Council outside Echt.

Garlogie Speed Limit Reduction: Roads replied to MSP Alexander Burnet on 4th August indicating that the proposed reduction would be put on the Infrastructure Services Committee agenda in November or January.

Winter Grit Bins: The removal of the grit bins is currently on hold.
